THIS LICENSE AGREEMENT IS BETWEEN BORN TO GET IT PRODUCTIONS AND THE PERSON OR PARTY ("LICENSEE") THAT HAS PURCHASED A BORN TO GET IT PRODUCTIONS INSTRUMENTAL (FROM 16DOLLARBEATS.COM). BORN TO GET IT PRODUCTIONS AND LICENSEE AGREE TO THE FOLLOWING TERMS AND CONDITIONS:

1. LICENSEE AGREES TO PAY BORN TO GET IT PRODUCTIONS THE ONE TIME INITIAL PURCHASING FEE. NO ROYALTIES WILL EVER BE OWED.
2. LICENSEE SHALL HAVE THE RIGHT TO SELL AN UNLIMITED NUMBER OF COPIES OF THE WORKS THEY HAVE CREATED WITH THE BORN TO GET IT PRODUCTIONS MUSIC.
